3. MEDICAL STADARD: Candidates will be subject to a medical examination by Railway Authority as prescribed for the appropriate category for the post prior to their appointment.
4. Service will be terminated immediately in the event of posting of selected candidates through RRB in the respective category.
5. Posting will be given against work-charged post and will be terminated on the expiry of period/currency.
